Conditions of Participation for "70-years FLUX Competition"

The following conditions apply:

1. Organiser

2. Participants

5. Winner selection and notification

The winners are selected at random in a lottery.

The winners are notified using the contact details provided during participation. The contact details cannot be changed after initial disclosure.

In the event that a win notification cannot be delivered, FLUX is not obliged to make any further enquiries; no claim to the prize can be made in such a case.

6. Exclusion of participants

FLUX reserves the right to exclude participants who provide incorrect or incomplete information, who make use of unauthorised means, who are suspected of manipulation or who in any other way violate the conditions of participation, from participation without stating any reasons.

If the conditions for exclusion have been fulfilled, prizes may subsequently be revoked or any prizes that have already been paid out or handed over may be reclaimed.

FLUX reserves the right to request that the participant submit his/her comments if there is reason to believe that there are grounds for exclusion. If the participant fails to provide his/her comments within the deadline set by FLUX, FLUX reserves the right to exclude the participant from participating.

10. Modification/cessation of the competition
